

CITY DUMPSITE AND BURNING WITHIN CITY LIMITS

During this time of the year many residents take this opportunity to do yard maintenance. The city has a dump for landscape waste that can be dumped without charge. The location for this is on E Lytle it is the first left after the Brushy Fork.

For those residents that desire to burn landscape waste please note that according to our municpal code it's unlawful to burn leaves, paper, rubish or other substance on any public street, sidewalk or alleys. As well as allowing the open burning of agricutural wastes, household trash or garbage.

REMINDER ABOUT PETS

We know the value of a family pet for companionship and enjoyment. But at times the City finds itself required to enforce municipal codes for the safety and wellbeing of all Newman residents and other animals. For full information regarding animals within the city limits we strongly recommend that you check out the Municipal code (Chapter 3; Animals) found on the City's website. Some items that we want to point out are the following:

The owner or keeper of a dog shall keep the dog under restraint at all times and shall not permit such dog to be at large, off the premises of the property of the owner or keeper, unless the dog is under complete control as defined in Section 3-1-2. (65 ILCS 5/11-20-9)
